## BARWOOD HOMES ASSOCIATION, INC. GUIDELINES FOR FENCING

## STATE OF TEXAS

#### KNOW ALL PERSONS BY THESE PRESENTS:

### COUNTY OF HARRIS

WHEREAS, the Barwood Homes Association, Inc. ("Association") is charged with administering and enforcing those certain covenants, conditions and restrictions contained in the recorded Declarations for the various sections of the community (referred to collectively as "Declarations"); and

WHEREAS, the Board of Directors of the Association ("Board") desires to establish a policy for Fencing to provide clear and definitive guidance to owners.

NOW, THEREFORE, the Board has duly adopted the following Fencing Policies.

- 1. All fences built must be approved by the Architectural Control Committee prior to construction
- 2. Fences must be of wood (no iron or chain link) except for gates.
- 3. Iron gates which can be seen through must offer a beautiful viewing area behind
- 4. Neighbors must match the height of their fences for greater uniformity
- 5. Fences shall be no higher than  $6\frac{1}{2}$  feet
- 6. Any fence viewable from the street must have the smooth side facing out.
- 7. Fences can be no closer than five (5) feet from the closest edge of the sidewalk.
- 8. We require that the fence contains three (3) cross boards for re-enforcement plus a rot board at the base
- 9. Fences cannot extend further toward the street than the front of the home.
- 10. Fences must consist of 1" x 6" treated wood runners (preferably cedar)
- 11. It is recommended that neighbors share the cost of the fence when it divides their yards

Approved and adopted by the Board on this 21st day of January 2020.

## **2020 POOL SEASON – PROJECTED OPEN JUNE 9**

Our summer pool season is going to be a lot different than previous years due to the COVID virus.

- + At the current time the pool will be opened at 25% capacity.
- All residents will have to sign a waiver and bring it with them every time they go to the pool along with your pool tag.
- + There will be no furniture at the pool. You can bring your own if you desire.
- Lifeguards will disinfect gate entry, check in area and restrooms hourly. They will clean and disinfect stands, handrails, surfaces, restrooms, pump rooms, guard rooms, all doors, etc. each evening.
- + The pool may be closed if a staff member becomes sick or needs to quarantine.
- Everyone is expected to maintain social distancing (6 feet) and not come to the pool if they are feeling unwell.
- + All patrons should wear a face covering when not in the water.
- + Restroom usage will be limited to one household at a time.
- + Guest usage of the pool will not be permitted.
- + Drinking fountain will be closed.
- + Pool parties are not permitted.
